

Registered Membership Application Handbook for Route 1 Educational Achievement

If you wish to apply by Route 2 – short courses and case study or Route 3 - two case studies please download the handbook for applications by Route 2 or 3

1. Who can apply for registered membership via Route 1 – Educational Achievement?

Current members of ACPOHE who have undertaken a second degree or Masters level study to a certificate level or above in a relevant field of study are eligible to apply via route 1. Examples of broad areas of study are:

- Occupational Health
- Health and Safety
- Ergonomics
- Vocational / Occupational Rehabilitation

You will need to demonstrate that you have undertaken development in the specialty by providing your Certificate that demonstrates your educational achievements.

You will need to demonstrate that you are working in the field by asking 2 referees with whom you have worked with in occupational health or ergonomics to complete and send in a reference for you.

2. Which Masters level courses are acceptable?

There are a number of UK based Masters level educational courses that develop knowledge and skills in the work and health field.

Members who have achieved an M level Certificate, Diploma or MSc in a relevant subject may apply for registered membership by submission of their qualification certificate.

The qualification should be from one of the UK university courses on the ACPOHE list. This can be found in the members zone of the ACPOHE website www.acpohe.org.uk in guidance documents ACPOHE Guidance on Educational Courses

We are aware that some courses have been discontinued. We have a short but not comprehensive list of discontinued courses on the website in the members zone under registered membership and also in Appendix 3. If your qualification is in ergonomics (applied / health) occupational health, health and safety, vocational rehabilitation, occupational rehabilitation from a UK university please apply.

Members who have achieved a postgraduate qualification in an allied subject from another university will be considered but must provide a full academic transcript for their course.

3. Application Instructions

There is no fee to pay until 1st April 2013 so all you need to do is

- 1. Request two professional references which should be sent direct to ACPOHE admin office
- 2. Send a copy of your certificate of educational achievement signed by a professional colleague to state they have seen the original to the ACPOHE admin office by post or email. If you email please request a read receipt

4. The benefits of registered membership

The main benefit of registered membership is recognition of your extended knowledge and skills in the specialist area of Occupational Health and Ergonomics. In addition:

- Your registered status is flagged on the Find a Physio area of the ACPOHE website
- You will be able to use the ACPOHE registered member badge and logo to indicate your registered status within ACPOHE and you will be issued with a certificate that confirms registered status
- You will be able to state that you are a registered member of ACPOHE.

In addition you will be:

- Eligible for entry to the list of ACPOHE mentors who support full members wishing to work towards registered status
- Eligible to apply to be a tutor for ACPOHE courses

Once registered, ACPOHE expects you to undertake a minimum of 10 hours CPD annually in the specialist field of Occupational Health and Ergonomics. ACPOHE reserves the right to request that Registered Members produce evidence of their CPD activities.

5. Post registration information

When you renew your membership in the year after you have registered you will need to pay £75 which is the annual membership fee for a registered member. Please ensure you select the correct subscription rate when you renew your membership. If you have a standing order please ensure you change it to £75 per annum.

Once registered, ACPOHE expects you to undertake a minimum of 10 hours CPD annually in the specialist field of Occupational Health and Ergonomics. ACPOHE reserves the right to request that Registered Members produce evidence of their CPD activities.

You can use the ACPOHE competency framework to check that you are working at Level B or above in the domains and elements of domains relevant to your case studies. This can be found in the members zone, under competency framework.
