ACPOHE Annual report 2021–22

Executive Summary

This report covers the period following our last AGM on 2nd of December 2021 which was held online due to COVID restrictions, to date.

In previous years ACPOHE has focused on laying down strong foundations and structure. This year has been a year of transition, both in terms of new and retiring committee members working closely together and ACPOHE committee consolidating work streams and developing core organisational areas.

As the new chair of ACPOHE, I have been keen to develop the structure of the ACPOHE committee to ensure our overall objectives are met and future developments achieved. We have a number of longstanding committee members retiring in November this year. To ensure a smooth handover, new members have been working closely with their predecessor to ensure they understand the role and clear development plans are in place. The new committee structure will be presented at the upcoming Study Day in which development plans will also be discussed.

As covid restrictions have lifted, the ACPOHE committee have adopted a hybrid approach to committee meetings, meeting both in person and remotely. This has increased efficiencies for committee members and allowed for more regular communication.

The committee continues to work towards its overall vision and objectives as detailed in the ACPOHE strategy. The work outlined in this report is aligned with these workstreams and we hope that the sections in the report will illustrate the efforts taking place to support you, our valued members.

Specific areas of development this year include;

- The development and launch of the ACPOHE Learning Management System (LMS) which hosts all ACPOHE training and offers a platform for regular communication and discussion within the membership.
- Training FCP's on work and health issues including the completion of the AHP Fitness for Work Report. This work was funded by the CSP and further funding has been granted to support the recent changes to the Fit Note. This opportunity has put ACPOHE in a strong position to work closely with the CSP, other professional networks and wider OH community, continuing to widen our reach as an organisation.
- ACPOHE's innovations during the global pandemic have been continued with a regular webinar series and online training programs which the membership has engaged in. We plan to continue this in the future as these innovations have proven to be of benefit to the membership, creating greater accessibility and communication.





 ACPOHE is keen to develop our membership, and this year we have had a particular focus on the student population. We want to continue to develop for new and existing members and ensure we deliver what our existing membership wants and needs, we welcome member feedback on this topic.

In the coming year we have a number of exciting development plans includina:

- More efficient and effective communication pathways
- Introducing methods of quality assurance and mentorship for our membership
- Further development of relationships we other CSP professional networks and other OH professions, to promote the work we do as Occupational Health Physiotherapists.
- Ongoing education with a focus on hybrid teaching methods and introduction of new training courses
- Strategic development for research in Physiotherapy in Work and Health

An in person ACPOHE study day is planned for November 2022. This will be the first opportunity to bring the ACPOHE membership together in 3 years. We encourage all members to attend and look forward to seeing you for a day of education, discussion, networking and social engagement.

I would like to take the opportunity to thank retiring committee members including; Kathy Roberts, Tracey Atkinson, Heather O'Neil, Jon Dance and Laran Chetty. Each one of these members has served on the ACPOHE committee for a number of years, offering their time, dedication and expertise to their roles. They will be greatly missed on the committee but will hopefully remain active within ACPOHE.

Finally, I would like to thank the whole committee for their ongoing support and commitment. Without this, the progress that has been made and our future development plans would not be possible. Equality, Diversity & Inclusion Report

General Summary:

Pay and Grading

General Summary:

Over recent years, guidance from the Chartered Society of Physiotherapy (CSP) is that the main benchmark on pay and grading, in any sector, needs to meet or exceed Agenda for Change (AfC). In England and Wales, an AfC pay award was made in late July following which the CSP ran a consultative survey with members, to take views on opposing the award. Reviewing these results, it was agreed that the CSP should move to an industrial action ballot and the CSP Council recommended that members should vote in support of action. This follows on from the decision already taken to ballot in Scotland. There has been no award made yet in Northern Ireland due to the ongoing lack of an Executive.

Key Activity:

ACPOHE's Pay & Grading Working Group have met over the past few months to follow these developments, and have decided not to wait for the outcome of any possible industrial action, since the cost-of-living crisis is here and pay rises are needed now. The group have considered the AfC pay award and looked at other influencing factors such as inflation rates, and have put together a proposal for the ACPOHE committee to discuss and review. We aim to have the Pay and Grading Report for 2022-23 published on our website in the coming weeks.

General Update

Communication **Website and Social Media Report**

General Update

The ACPOHE website and social media platforms have the following primary objectives:

- 1. As an outward facing representation of physiotherapists working in Occupational Health.

- 3. To facilitate the promotion of occupational health physiotherapy as an exciting career path.
- 4. As a tool for our members to improve their practice and remain abreast with recent OH specific activities.
- 5. To be innovative and future fit.

Key Activity:

Website:

- With the re-starting of courses post pandemic and the introduction of mor regular webinars the traffic to the website has increased this year.
- Courses and Webinar pages are the most regularly visited pages.
- More regular updates and content with the assistance of the admin function, Nik Bathe, has helped keep the website up to date and continually stimulating visits.
- Driving visitors to the website (rather than direct to registration/ booking pages) when advertising/promoting courses and webinars seems to facilitate increased traffic.

Social Media:

ACPOHE continues to promote activity and share information across a number of social media platforms. We encourage all ACPOHE members to engage and share ACPOHE all posts.

A summary of the activity across the individual platforms can be found below:

Twitter:

- Twitter is ACPOHE's most utilised social media stream and sits well with the current trend within physiotherapy to network, share views and discuss topics and research on this platform.
- @ACPOHE has had an increase in 100 followers over the past 12 months. Now 976.
- Monthly impressions are regularly between 4,000 8,000.





- May was the busiest month on Twitter with 28,000 impressions attributed to hosting, promoting and tweeting about two webinars: Long Covid and FCP.
- Conferences, networking events and webinars consistently produce @ACPOHEs best results on Twitter, which translates over to website
- With The Health and Wellbeing at Work conference and PhysioUK both being virtual over the past 12+ month, the usual social media content created at these events has been limited.

LinkedIn:

- The ACPOHE LinkedIn account (https://www.linkedin.com/company/acpohe/) has doubled its number of followers in the past year, currently standing at 143.
- Engagement by members is generally low but we continue to use it mainly for raising awareness of ACPOHE courses and webinars.

FaceBook:

- ACPOHE's Facebook account (https://www.facebook.com/ACPOHE) has shown a small increase in likes over the year, currently at 291.
- As with other social media accounts, engagement is low but we continue to use it mainly for raising awareness of ACPOHE courses and webinars.
- Posts are shared in other FB groups such as Physiotherapy UK, UK Occupational Health Practitioners, and Physio and Therapist Support groups.

iCSP:

- ACPOHE continued to use iCSP to promote courses and webinars.
- ACPOHE regularly provide comment, advice and signposting to iCSP posts on health and work topics

Further Developments:

Canva is being used to create posts and schedule them across multiple social media platforms with some success.

Future Plans:

- A more structured plan for outgoing social medial content is in the making with ideas to try and get better engagement from our members.
- Discuss and consider what additional type of content, news and article may want to include in the News section of the website.
- All sections of the website need to be reviewed and content updated and 'tidied' by the respective committee members.

Research

General Update

Research continues to be a growing area for ACPOHE. This year the team prioritised working to support the student network and build a research network within. We also worked on a mentorship scheme and on student placements.

Key Activity:

- Research placement development between the University of **Brighton and ACPOHE**
- Training opportunities available for ACPOHE members on opening up placements with physiotherapy students
- Supporting research activities and taking part on research projects
- Submission of funding proposal for mentorship scheme
- Collaborative project between CSP student officer and ACPOHE in promotion of health and wellbeing a work using physiotherapy cohorts.
- Current ongoing research project A survey study to determine research priorities in OHE among the ACPOHE members community (Waiting for ethical approval). The results will support the development of case study writing resources for ACPOHE members and facilitate sustainable deliverables/submission of scientific work to ACPOHE journal
- Ongoing research collaborations between ACPOHE, CSP, Universities and Students
- Submission of a funding proposal for mentorship scheme as a PN network





Future Plans:

ACPOHE plan to introduce a Research Community Café. This is currently under development and aims to be launched in the January. 2023.

ARC

The Annual Representative Conference (ARC) is an opportunity for CSP members to come together for two days to discuss and debate matters of importance to members, the services they offer and the health and welfare of the community. It is ACPOHE's opportunity to have its say and influence the CSP's policies and direction.

ACPOHE proposed 2 motions at ARC 2022 in Manchester, namely: (1) The right to disconnect, and (2) Occupational health in the pre-registration curriculum.

Both motions were passed at ARC. We await feedback from the CSP Council on how to proceed.

Council for Work and Health

Nicola Suckley continues as Board Director for the Council for Work and Health. This ensures ACPOHE now has a strong recognition within the organisation.

Members of the committee continue to have a presence at the quarterly Council meetings where we promote the role of physiotherapy in the wider Occupational Health landscape. We would encourage our membership to visit their website to learn more about the Council's activities.
